SUBJECT

AUTHORITY TO CONDUCT AND PARTICIPATE IN THE

MODERNIZED PHILIPPINE GOVERNMENT ELECTRONIC PROCUREMENT SYSTEM (PHILGEPS) FOR PHILIPPINE RURAL

DEVELOPMENT PROJECT (PRDP)

Republic Act No. (R.A.) No. 9184, otherwise known as the "Government Procurement Reform Act" and its Revised Implementing Rules and Regulations (IRR), mandate that procurement process shall be simple and made adaptable to advances in modern technology in order to ensure an effective and efficient method and transparency. As such, the Philippine Government Electronic Procurement System (PhilGEPS) supports the implementation of Electronic Bid (eBid) Facility which will cover all types of procurement for goods, infrastructure projects and consulting services through electronic means. Further, the Government Procurement Policy Board (GPPB) issued Resolution No. 10-2022, "Conditionally Approving the Pioneer Implementation of the Electronic Bidding Facility in the Modernized PhilGEPS for Fiscal Year 2023".

Pursuance thereof, the PRDP is hereby authorized to conduct "**Training on Modernized Philippine Government Electronic Procurement System (mPhilGEPS) for PRDP**" on March 19 to 22, 2024 in Region IV-A.
