Duties and responsibilities:

1. Head Focal
 - a. Assess and review all submitted documents before submission to Department of Agriculture - Disaster Risk Reduction and Management Service (DA-DRRMS);
 - b. Maintain a validated list of ASF-affected hog raisers and respective number of affected hogs and other information taking into consideration the PCIC-insured raisers;
 - c. Ensure accurate distribution of indemnification to affected hog raisers; and
 - d. Perform other tasks as needed.
2. Focal for Documentary Requirements / Supporting Documents
 - a. Collate all the submitted documentary requirements such as laboratory results, disease investigation reports, and other documentary requirements from the Local Government Unit and other offices; and
 - b. Perform other related tasks as needed.
3. Focal for Funding
 - a. Prepare and review financial documents to facilitate the processing of indemnification to ASF-affected hog raisers; and
 - b. Perform other related tasks as needed.

This Order shall take effect immediately and shall remain in force unless revoked in writing. All orders, memoranda, and other issuances inconsistent herewith are deemed revoked.
