The Assistant Secretary for Policy and Regulations shall serve as its Chair, with the Office of the Assistant Secretary for Policy and Regulations serving as the Secretariat.

All expenses to be incurred in the performance of the functions, duties, and responsibilities of the members of the GARA shall be charged against their respective agencies' funds, subject to the usual auditing rules and regulations.

This Order shall take effect immediately and shall remain in force until revoked in writing. All orders, memoranda, and issuances inconsistent with herewith are deemed revoked.
