## SPECIAL ORDER No. <u>477</u> Series of 2024

## SUBJECT: CREATION OF TECHNICAL WORKING GROUP ON THE REVISION OF THE NATIONAL GUIDELINES ON THE ISSUANCE OF PERMIT TO OPERATE AND CERTIFICATE OF CONFORMITY

The Bureau of Agricultural and Fisheries Engineering (BAFE) is currently spearheading the updating/revision of the Department Circular No. 19, Series of 2018, "Guidelines on the Issuance of Certificate of Conformity for Agricultural and Fisheries Machinery", and Department Circular No. 04, Series of 2019, or the Guidelines on the Registration and Issuance of Permit to Operate for Agricultural and Fisheries Machinery Manufacturers, Fabricators, Assemblers, Distributors, Dealers, Importers, and Exporters which aims to address the issues and concerns on the existing guidelines and to make the Guidelines relevant to the current requirements of the agricultural and fisheries machinery industry.

Relative to this, a Technical Working Group (TWG) is hereby created and shall be composed of the following:

Functions of the Secretariat:

- 3. Coordinate with TWG Members regarding the schedule of activities, updates on the project and other related concerns; and
- 4. Provide other necessary services and support to the TWG.

Expenses to be incurred like food, transportation, and accommodation shall be charged to the funds allocated to BAFE, subject to its availability and usual government accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in force unless otherwise revoked in writing. All orders, memoranda, and issuances inconsistent herewith are hereby revoked.
