- 2. Review of Bidding Documents;
- 3. Shortlisting of Consultants;
- 4. Eligibility Screening;
- 5. Evaluation of Bids;
- 6. Post-Qualification; and
- 7. Resolution of Request for Reconsideration.

The BAC TWG shall be entitled to traveling expenses and honoraria chargeable against BSWM funds, subject to availability of funds and existing government accounting and auditing rules and regulations.

This Order shall take effect immediately and shall remain in force unless revoked in writing. All orders, memoranda, and other issuances inconsistent herewith are deemed revoked.
