## SUBJECT: AUTHORITY TO CONDUCT AND PARTICIPATE IN THE DEVELOPMENT COMMUNICATION TRAINING OF THE SPECIAL AREA FOR AGRICULTURAL DEVELOPMENT (SAAD) PROGRAM PHASE 2

The Special Area for Agricultural Development (SAAD) Program – Phase 2 is hereby authorized to conduct a Cluster-wide Development Communication Training as part of the FY 2024 activities of the SAAD Program – Phase 2.

The activity aims to capacitate SAAD officers at the national to local level with the concepts and practices of development communication. Specifically, it aims to:

- 1. Strengthen the knowledge awareness of SAAD Officers on the concepts and practices of development communication;
- 2. Develop practices using development communication strategies which will increase the knowledge awareness of the SAAD beneficiaries and stakeholders on the SAAD Program;
- 3. Complement the functions of the DA-SAAD Public Relations and Development Communication (PRDC) with the development communication processes;
- 4. Actively engage with the SAAD beneficiaries and collaborators, and integrate innovative communication strategies, thereby ensuring the effective dissemination of information within the SAAD Program; and
- 5. Craft communication plans and develop on IEC material tailored-fit for SAAD farmer-beneficiaries.
