SUBJECT: AUTHORITY TO CONDUCT AND ATTEND THE SELECTION ACTIVITY OF THE 2024 NATIONAL FISHERFOLK DIRECTOR AND REGIONAL FISHERIES AND AQUATIC RESOURCES MANAGEMENT COUNCIL (FARMC) COORDINATORS' PLANNING WORKSHOP ON APRIL 17-19, 2024

In the interest of service, the Information and Fisherfolk Coordination Unit – Fisherfolk-FARMC Coordination Office of the Bureau of Fisheries and Aquatic Resources (BFAR) is hereby authorized to conduct and attend the Selection Activity of the 2024 National Fisherfolk Director and Regional FARMC Coordinators' Planning Workshop on April 17-19, 2024, in Metro Manila.

Pursuant to Presidential Proclamation No. 33, s. 1989, the month of May every year is declared as "Farmer's and Fisherfolk's Month". It is a month-long celebration in recognition and tribute to the farmers and fisherfolk who tirelessly toil our land and seas.

In support to the celebration, the DA-BFAR, by virtue of Special Order No. 88 conducts the annual "Mangingisdang Direktor" activity as a platform to highlight the crucial role of the country's fisherfolk sector in sustainable fisheries management and development.
