SUBJECT: CREATION OF DA TECHNICAL WORKING GROUP AND SUB-COMMITTEES FOR THE 126TH CELEBRATION OF PHILIPPINE INDEPENDENCE

Administrative Order No. 08 series of 2023 signed by President Ferdinand R. Marcos, Jr. enjoins all departments, agencies, bureaus, offices, national government agencies (NGAs), and government-owned or controlled corporations to give full support and assistance to the Inter-Agency Committee created for the commemoration of the 125th Anniversary of Philippine Independence and Nationhood from 2023 to 2026 with the theme “Kalayaan, Kinabukasan, Kasaysayan”. This year’s celebration of the 126th Philippine Independence, the Department of Agriculture (DA) is tasked as head of the cluster, which includes the departments and government offices such as the DENR, DAR, DOE, DTI, DOT, ARTA, and CCC. 1. Prepare and finalize the activities and funding requirements in relation to the participation of the DA in the 126th celebration of the Philippine Independence for the approval of the Secretary;
2. Coordinate with the National Historical Commission of the Philippines (NHCP) and other agencies in the preparation of the DA activities/cluster for the event;
3. Perform other tasks as needed.

Expenses for the preparation and participation in the event shall be charged against OSEC and other available funds, subject to usual government accounting and auditing rules and regulations.

This Order shall take effect immediately and shall be considered revoked upon the completion of the event. All orders, memoranda, and other issuances inconsistent herewith are deemed revoked.
