**SUBJECT: AUTHORITY TO CONDUCT AND PARTICIPATE IN THE FISHERIES NATIONAL ADMINISTRATIVE REGISTER (FNAR) AND REVIEW OF THE RULES OF PROCEDURE FOR THE ADJUDICATION OF FISHERIES LAW CASES (RPAC)**
