**SUBJECT AUTHORITY TO CONDUCT AND PARTICIPATE IN THE


The participants in the attached document are hereby authorized to participate in the activity.

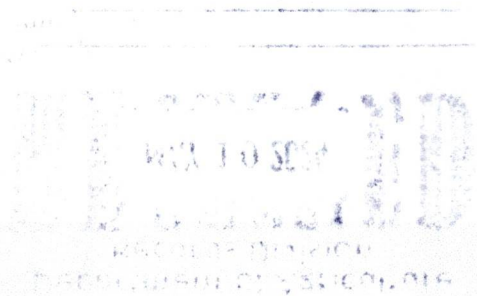
