AUTHORITY TO CONDUCT AND PARTICIPATE IN THE STAKEHOLDERS' REVIEW AND CONSULTATION OF THE IMPLEMENTATION AND UPDATING OF THE NATIONAL TUNA

MANAGEMENT PLAN (NTMP) 2019-2023

In the interest of the service, the Bureau of Fisheries and Aquatic Resources is hereby authorized to conduct and attend the Stakeholders' review and consultation of the implementation and updating of the National Tuna Management Plan (NTMP) 2019-2023 on 29-30 May 2024 in Quezon City.
